

**RELEASE AND WAIVER OF LIABILITY,  
ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT**

In consideration of being permitted to participate in the Americans For a Safe Israel's (Organization) Chizuk Mission to Israel **beginning on May 15, 2023, and ending on May 22, 2023**, ("Activity") I, for myself, my personal representatives, assigns, heirs and next of kin:

1. Acknowledge, agree and represent that I understand the nature of the Activity and that I AM QUALIFIED, IN GOOD HEALTH, AND IN PROPER PHYSICAL CONDITION TO PARTICIPATE IN SUCH ACTIVITY. I further agree that if, at any time, I deem myself physically unfit for the Activity, that I will withdraw from participation.
  
2. Fully understand that this ACTIVITY WILL BE TAKING ME INTO AREAS WHERE THERE IS A RISK OF DANGER IN THE FORM OF TERRORIST AND/OR OTHER WARLIKE ACTION AND THIS ACTIVITY
  - a. May result in PHYSICAL, EMOTIONAL OR MENTAL HARM TO AN EXTENT UNDETERMINED BUT NOT PRECLUDING SEVERE DAMAGE AND DEATH.
  
  - b. THESE RISKS AND DANGERS MAY BE CAUSED BY MY OWN ACTION OR INACTION OR ACTION OR INACTION ON THE PART OF OTHERS IN WHETHER OR NOT EMPLOYED BY OR CONTRACTED WITH OR INVITED BY THE ORGANIZATION OR NEGLIGENCE of any of the above-named actors.
  
  - c. There may be other risks of social and economic losses either not known to me or not readily foreseeable at this time and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I incur as a result, either direct or indirect, OF MY PARTICIPATION IN THE Activity.
  
3. HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE the Organization, their administrators, directors, agents, officers, members, volunteers, employees and other participants in this mission FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNTS CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY ANY ACTION OF THE RELEASEES, INCLUDING NEGLIGENT RESCUE OPERATIONS.
  
4. I FURTHER AGREE THAT IF DESPITE THIS RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT, I OR ANYONE ON MY BEHALF MAKES A CLAIM AGAINST ANY OF THE RELEASEES, I WILL INDEMNIFY AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, or cost which may be incurred, as a result of such claim.
  
5. I ACKNOWLEDGE THAT I AM AGE 18 OR OLDER, HAVE READ THIS AGREEMENT AND FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, HAVE SIGNED IT OF MY OWN FREE WILL WITHOUT INDUCEMENT OF ANY NATURE AND I INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS TO BE HELD INVALID, THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT.
